Stock Contractor Request for Bid

RODEO DETAILS:

Keystone Junior Rodeo Association (KJRA) is accepting bids for stock for our 2019 Rodeo season. Rodeo dates are as follows:

May 4th and 5th
June 8th and 9th
August 3rd and 4th
August 24th and 25th
September 7th and 8th
October 12th and 13th

Saturday Rodeos begin at 10:00 am, Sunday Rodeos begin at 9:00 am

BID TERMS AND CONDITIONS:

The Rodeos will not be a place to 'train' or 'break-in' stock. All stock must have previous rodeo experience.

Chute Doggin and Team Roping steers should be even in weight, horn length and size.

Tie-down Roping calves should be smaller than Breakaway Roping calves and even in weight and size.

Chute Doggin steers shall have horns tipped and be even in weight and size, no greater than 550 lbs.

Goats shall be uniform in size and weight, not to exceed 50 lbs. for 7-18 y/o contestants. Further, smaller goats shall be provided for 6 y/o and younger contestants.

HAY / FEED: Contractor is required to supply sufficient hay and grain for stock.

ENTRIES: To assist with estimations, below are the average entries for our 2018 season.

Bull Riding - 0	Breakaway Roping - 32	Chute Doggin - 11
Calf Riding - 8	Calf Roping - 6	Goat tying - 6 and Under - 14
Steer Riding - 2	Team Roping - 15	Goat tying - 7 y/o - 18 y/o - 40

KJRA Rodeo Secretary or designee will contact contractor within 5 days prior to the start of the rodeo to turn in stock numbers based on entries received.

Stock contractor is required to bring enough stock for each rodeo and events.

KJRA will not be held responsible or liable for stock that suffers illness, injury or death during rodeos.

All Arena help, Announcer, Chute helpers and Stock Pen helpers shall be furnished by KJRA.
